I am directed to state that the Board of Governors at its meeting held on 11.02.2019 considered the Compliance Verification Assessment report (12.11.2018) along with the Council Assessor's Report(s) (August, 2017) and compliance dated 23.03.2018 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Physiology) qualification for 2 seats at Rama Medical College and Hospital, Kanpur, Uttar Pradesh granted by Dr B R Ambedkar University, Agra, U.P. and decided as under:-

"The Board of Governors considered the compliance verification assessment report (12.11.2018) along with the Council Assessor's Report (August, 2017) and compliance dated 23.03.2018 submitted by the college authorities together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MD(Physiology) qualification for 2 seats granted by Dr B R Ambedkar University, Agra, U.P. in respect of students being trained at Rama Medical College and Hospital, Kanpur, Uttar Pradesh be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
